## Notes

The above fees exclude GST. Please note that GST is not charged if the contract/agreement to provide services is with the client/individual receiving the services, otherwise GST will be charged.

Minimum shift charges may apply, as well as minimum hours of support for certain services.

Prices are generally calculated on an hourly rate, with the exception of Short-Term Accommodation which is a daily rate (24 hours) and establishment fees which are a one-off payment.

Price varies based on time of day and day of week. Weekday is defined as Monday – Friday 6:00am – 8:00pm. Weekday Afternoon and Evening is defined as Monday – Friday 8:00pm – 12:00am. Weekday Night is defined as Monday - Friday commencing at or before midnight and finishing after midnight, or support commencing before 6:00am. On Saturdays, Sundays and Public Holidays there is only one hourly rate for services from 6.00am-12.00am. A Night-time Sleepover Support is any support delivered on weekdays, Saturdays, Sundays or Public Holidays that commences before midnight and finishes after midnight the next day, is for a continuous period of eight hours or more, and the worker is allowed to sleep when they are not providing support. This support includes up to two hours of active supports for the duration of the period. Centacare will claim for a third or additional hour at Saturday rates on weekdays, or at applicable rates on Saturday, Sunday or Public Holidays.

A cancellation fee may apply if you cancel a service at short notice as per the NDIS Price Guide.

Where applicable, prices include the Temporary Transformation Payment (TTP). This payment is designed to assist providers who meet specific criteria, to transform their business operations to respond to the needs of clients and help them achieve their goals in line with the new NDIS framework. Centacare is a registered NDIS Provider and meets the requirements to charge the TTP rate.

Intensity of support is based on the level of assistance a client requires from a support worker or other staff member, to assist with managing challenging behaviours or providing medical support primarily.
